Applications are due in the Office of Academic Deans by December 1st (for following academic year).

Fees and Financial Aid

Students on exchange pay the tuition and fees of the host school, to the host school. Federal financial aid can apply, but Mount Holyoke financial aid does not travel.

Application Process and Timeline

Signed and completed applications for the Twelve College Exchange Program are due in the Office of Academic Deans, 300 Mary Lyon Hall, on **December 1st** for the following academic year (fall semester, spring semester, or full year).
